

Michael Blackwell LL293 Tax and Tax Avoidance - Group 1 No. of responses = 16


Class/Seminar Teacher Evaluation

- Delivery of course content could have been made more interesting, because lessons were rather poorly and loosely structured.
- I think the class needs to be a bit more structured
- It felt that the classes lacked structure, so in some cases it was difficult to tell what are the key issues that we should be focusing on.
- Lack of lectures makes understanding more difficult
- More could have been done to involve all members of the class in discussion. Especially in LT, I found it difficult to follow the topic throughout the class as there was a tendency to start with a detailed analysis of legislation without having a sort of overview of the topic and its application. Signposting and the structure of seminars could be improved.
- More structure to classes list of questions to go through each week relevant to the readings would be helpful Lectures and classes rather than just seminar
- More use of slides and clearer notes for later topics

- The teacher often seemed to be unprepared and his presentations were therefore chaotic with the structure of the topic being really difficult to follow. This made understanding the subject difficult, which is problematic given the technical nature and complexities of tax law.



Perhaps, a list of terms and questions regarding a particular topic could do. Sometimes, these were distributed before our classes but many times, these were unavailable.
- Lectures and classes rather than just seminar teaching
- More focus on particular topics, rather than giving us hundreds of pages to read every week without clarifying in the seminars the core issues and tensions whose identification could help us score high marks in the exam.
