## CURRENT RESEARCH PROJECTS

1. “Them and us: working class anger, rightwing populism and the failings of labour institutions in comparative perspective”

*Summary:* The project looks at workers’ perceptions of economic inequalities and right-wing populist sentiments across selected political economies and explores the deficiencies of labour institutions to tame populist working class anger even in economies with traditionally strong labour rights and welfare states. It asks for a critical re-evaluation of today’s labour institutions in balancing class and culture, thus progressive, post-materialist ideals with classic bread and butter issues in times of globalization.

2. “Integration of Migrants and Marriage: a Comparative Analysis”

(joint with Leonardo Felli (Cambridge), Maya Guell (Edinburgh), Sevi Rodriguez Mora (Edinburgh), and Yona Rubinstein (LSE))

*Summary:* There is a lively and heated debate about the integration of migrant communities in the US and different European countries. This project aims at adding a new insight in this debate by focussing on marriage. Using comparable data of the US and some European countries (UK, Germany, Spain and Italy) we aim at identifying the characteristics of the households where one of the partners is part of the local population while the other partner is a migrant. The aim is to understand how the characteristics of the migrant partner vary when compared to the characteristics of a comparable household where both partners are part of the local population. In particular, we want to identify the premium, in terms of personal characteristics (such as education, job placement, wealth, age etc...), that is associated with the migrant partner married to a partner in the local population. The idea is to compare this premium across different immigrant groups within the same country, so as to measure the level of integration of different migrant groups and assess whether this measure varies with race or religion. We also want to compare these measures across different countries once again focusing on how integration varies in terms of race, religion or flow of migration.
