This paper presents the main aspects of the University of Regensburg's proposal to organize ECIS 2005. This proposal will be submitted to the standing committee in Naples on February 22, 2003.

1. Objectives

ECIS should be a meeting place for European researchers in the field of information systems from various cultures and countries and should reflect the specific and innovative features of European research in information systems. Germany has a long tradition in the field of IS and is one of the largest and most well-known communities in this field. As ECIS has been supported by German researchers ever since its founding, it is surprising that it has never been held in Germany. Holding ECIS in Germany would be an excellent opportunity to develop and improve the relationship with this community.

The University of Regensburg was one of the very first universities to set up a separate institute for Management of Information Systems in 1994. This Institute has expanded in the meantime to five full professors in this field. Regensburg is proud to call itself one of the centres of the German IS community.

To be selected as host for ECIS 2005 would be an opportunity for the Institute for Management of Information Systems to show itself as an internationally aligned programme.

Conference Format

2.1. Conference Dates

We propose the conference dates of May 26-28 or June 9-11, 2005. The doctoral consortium would take place on May 23-25 or June 6-8, 2005. A welcome reception would be organized for the Wednesday before the first conference day. The conference dates are of course provisional and subject to changes by the organizing committee (see calendar for May 2005 below). On May 26 is Corpus Christi which eases planning a lot.

5.3. Costs

5.3.1. Doctoral Consortium

The doctoral consortium would start two days before ECIS 2005. There are many places in and around Regensburg where it could be held:

Hotel Zur Post in Tännesberg: Half an hour's drive away from Regensburg and located at an altitude of 700m, this hotel offers conference facilities with Internet access and is ideal for socialising events like hiking, visiting castles or short trips into the Czech Republic.

The *Thurn und Taxis* Castle: Equipped with state of the art technology this facility not only offers excellent meeting rooms but also offers a large park which can be used for socialising events like barbecues. Being centrally located, all leisure facilities are within walking distance. There are two hotels within 100m which could be chosen for accommodation.

We think that the first solution is best because it combines sleeping and conference facilities in one location and seems to be reasonably priced.

The hotel in Tännesberg offers conference facilities and Internet access. There is a special offer for conferences with a flat rate of € 250 per person for a three and a half day stay. The flat rate includes 3 overnight stays, 4 three-course lunch menus, 3 dinners with a selection of different meals to choose from, and two coffee breaks each day. The following budget plan is based on an estimated 25 participants and 5 faculty members.

7. General Information

7.1. Regensburg

Regensburg is located in the south east of Germany in the heart of Bavaria at the northern most point of the Danube river. With a population of 140,000 it is a suitable size for a conference like ECIS. This has been proved by many conferences of up to 5,000 participants which take place on a regular basis in Regensburg. Regensburg's high capacity hotel industry offers 4,000 beds in the city centre and 6,500 in the surrounding area.

Regensburg is easily accessible for visitors. The nearest airport, Munich, is connected to Regensburg via a shuttle bus, which takes about an hour for the trip. A smaller airport in Nuremberg is also about one hour away. The motorway junctions Munich-Berlin and Nuremberg-Vienna are close by, which makes Regensburg ideally accessible via car. The city also is served by the east-west European train network from Frankfurt to Budapest. Being centrally located, Regensburg is a perfect place to host a European Conference.

Regensburg offers many opportunities for an attractive social programme, e.g. a historical city centre, castles, boat trips on the Danube, excursions to the Bavarian forest, and tours of Audi's and BMW's production facilities.
